The talk will highlight the collaborative process working with towns and MassDEP and strategies to balance affordable housing and nitrogen reduction in watersheds.

Session One - Onsite Denitrification systems (enhanced I&A): Lessons Learned from implementation and practical support for towns.

Sara Wigginton, Massachusetts Alternative Septic System Test Center (MASSTC) will discuss the effectiveness and lessons learned from I&A systems using monitoring data collected from installed systems.

David Iorio Izzo, MASSTC will discuss how the Barnstable County Septic Utility Program (SUP) supports towns with I&A systems (e.g., monitoring, maintenance). Zee Crocker, Barnstable Clean Water Coalition will discuss the effectiveness of I&A systems to reduce nitrogen in groundwater and Shubael Pond.

Session Two - Urine Diversion: Lessons learned from implementation in Falmouth and larger scale implementation in Vermont.

Hilda Maingay & Earle Barnhart, The Green Center will discuss the importance of urine diversion in reducing nitrogen in waterways and will focus on community interest and inspiration for the pilot project in Falmouth.

Bryan Horsley, MASSTC will discuss the effectiveness of ecosanitation and urine diversion using the Falmouth pilot project data. The talk will highlight potential implications for other towns and what is needed to advance urine diversion implementation. Abe Noe-Hays, Rich Earth Institute will discuss their real-world implementation experience & scaling up (e.g., design, installation, maintenance) of urine diversion and composting toilet systems.

Session Three - Regional Shellfish Efforts to Reduce Nitrogen and Challenges with Scaling-up Production on Cape Cod.

Josh Reitsma, WHOI Sea Grant will present on realistic expectations for shellfish nitrogen removal, challenges, and factors to consider when scalingup production. Michael DeVasto, Wellfleet Selectboard member and commercial shellfish grower will share perspectives regarding aquaculture challenges towns should address as they consider including aquaculture as part of their nitrogen removal strategies. Tom Duncan, Falmouth Water Quality Management Committee and

Chuck Martinsen, Falmouth Marine & Environmental Services will present on oyster production and nitrogen capture in Eel River, Falmouth MA.

Ashley Fisher, Mashpee Division of Natural Resources will present on the lessons learned from shellfish aquaculture for nitrogen removal in Mashpee and recommendations for other towns.
